WELCOME TO GOOD GOVERNANCE FORUM 2020!

The Good Governance Forum (GG Forum) is an international high-level conference on good governance to be held on October 2, 2020. The Forum is organized by the Institute for Development of Freedom of Information (IDFI), in cooperation with the Open Government Partnership (OGP), with the support of the global philanthropic organization, Luminate. It is the second series of GG Forums held annually in Georgia since 2019 and gathers international experts, representatives of governments, civil society, the private sector and international community to advance the good governance reform agenda by raising awareness, exchanging best practices and fostering debate.

The 2020 GG Forum aims to explore innovative mechanisms and the most cost-effective approaches to ensuring political integrity, especially at a time of upcoming Georgia's parliamentary elections planned in October, 2020 in Georgia. The conference intends to do this by engaging local and international experts and stakeholders around several key related issues: electoral legislation and practice, political donations and political party financing, use of administrative resources during the election campaign, lobbyism and international transparency standards.

The Forum gathers experts and representatives of international and civil society organizations from different countries with best practices of developing integrity mechanisms as well as journalists and activists with the aim to exchange regional and international practices of ensuring political integrity. Such information and experience exchange will lay the foundation for future ambitious advocacy efforts in the region and beyond.

CONTEXT

As it is acknowledged globally, political corruption is the use of powers by government officials or their network contacts for illegitimate private gain. This type of corruption is very much related to political elections, as it involves the following category of illicit acts committed by decision-makers: illegal political finance, undue influence of policy-making, state capture, election fraud, vote buying, abuse of state resources during elections, etc.

Political corruption is a global challenge affecting all governments to a varying degree. For instance, it is argued that corruption related to political finance is relevant for both developed and developing countries, while abuse of office seems to be more prevalent for countries from East Europe and Central Asia and other regions.

Even in Georgia, which managed to achieve significant progress in eliminating petty corruption and introducing political party funding transparency standards over the past years, incidents of misuse of administrative resources, use of social and financial initiatives to attract votes, problems related to effectiveness of campaign¹ finance framework were identified among other shortcomings of the latest presidential election campaign. Georgia's case is not unique across the globe, suggesting that there is a real need to figure out efficient and innovative mechanisms that have the potential for ensuring electoral integrity.

Considering the fact that political will to implement new approaches to ensuring political integrity is hard to come by, especially on the high level, it is especially important to keep this conversation going and explore innovative, efficient and proper mechanisms that can be replicated relatively easily in different jurisdictions.

The conference will focus on the following key topics: electoral legislation and practice, political donations and political party financing, use of administrative resources during the election campaign, lobbyism and international transparency standards. The reasoning behind the selection of these topics is as follows:

TRANSPARENCY STANDARDS OF POLITICAL FINANCE:

In order to ensure fair competition between political parties, both campaign finance and routine party funding should be effectively regulated and enforced. The mentioned regulations should promote accountability, preserve the responsiveness of political parties and candidates, ensure that all parties have equal opportunity and minimize the danger of corruption, in particular, state capture and influence peddling. The Forum will focus on the

effectiveness of oversight mechanisms ensuring transparency of political party funding, what are best practices in this direction, challenges, current trends and opportunities.

USE OF ADMINISTRATIVE RESOURCES:



One of the major influences on electoral processes is typically the use of administrative resources. There is no commonly accepted definition of an administrative resource and its misuse for electoral purposes either in Georgian or in international law. However, based on various international standards and reports several types can be highlighted: use of human and non-monetary as well as budgetary resources of the central or local govern-

ment institutions, to support election campaign of certain political party or candidate, use of legislative, executive and judicial branches in favor of/against the electoral interests of a certain political party or candidate, increase in the funding of budgetary programs and social assistance to particular vulnerable groups for the upcoming election period, etc². Otherwise the line between the state and the party is considered blurred and weak. Therefore, it is important to overview international best practices, legislative frameworks and different solutions (e.g. effective complaint mechanism, existence of impartial and competent oversight authority, relevant enforcement measures) to address this challenge.

CORPORATE INFLUENCE ON DECISION-MAKING AND LOBBYISM:

There are several ways through which interest groups and large corporations try to influence the decision-making process. Interest group influence, commonly known as lobbying, is defined as "any direct or indirect communication with public officials, political decision-makers or representatives for the purposes of influencing public decision-making carried out by or on behalf of any organised group"..³ In most cases, interest group influence is

not a corrupt or illegitimate activity per se, but when opaque and disproportionate it may lead to undue influence, corruption and even state capture. To avoid these challenges, several integrity measures are advisable: regulations on lobbying, regulations on conflict of interest, regulations on political finance, rules on private sector competition, rules on transparent decision-making and access to information, etc. The Forum participants will overview contemporary trends, tendencies, challenges and best practices to cope with this problem.

She specializes in political parties, campaigns, candidate selection, and the survival of authoritarian parties after democratization.
