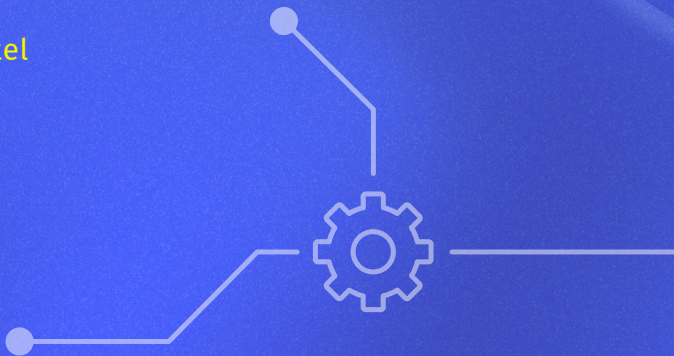

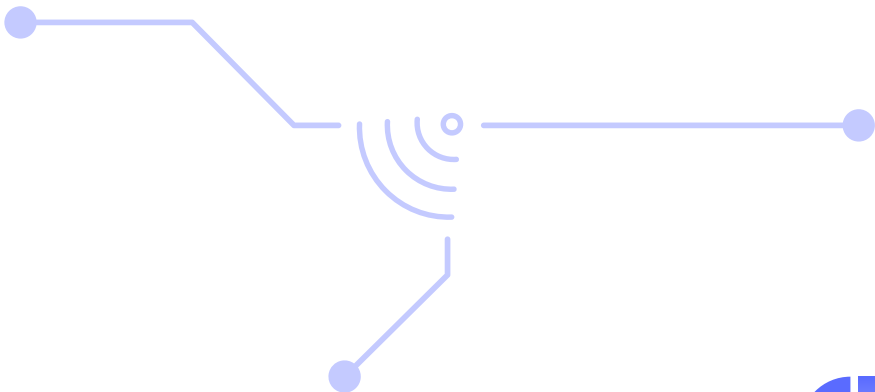
# WELCOME TO INTERNATIONAL HYBRID CONFERENCE

## DIGITAL TRANSFORMATION OF GEORGIA: PROACTIVE STEPS TOWARD EU ACCESSION

Digital Transformation of Georgia: Proactive Steps Toward EU Accession - is an international hybrid conference on digital transformation to be held on April 28, 2022. The conference is organized by the Institute for Development of Freedom of Information (IDFI), in cooperation with the Open Government Partnership (OGP), with the support of the global philanthropic organization, Luminate.

The conference aims to contribute to good governance and digital transformation reforms in Georgia by exchanging best practices, especially from Western, Central, and Southern European countries, and fostering debate on the digital transformation of public services, EU standardization, and key enablers and challenges of the digital ecosystem needed for effective digital transformation.

The event intends to do this by engaging local and international experts and all relevant stakeholders from various sectors around several key-related issues: digitalization of public services, public sector modernization, effective digital transformation, necessary digital ecosystem, EU standardization, and ambitious reforms in these regards.



## CONTEXT

---

On March 3, 2022, the Georgian government formally applied for EU membership. On April 11, the European Commission issued a questionnaire consisting of 369 questions to Georgia. The country has one month to complete this extensive document. Based on the questionnaire, the European Commission will prepare an opinion on the country's application for EU membership, on the basis of which the country may be granted candidate status. The questionnaire addresses key areas and reforms, such as public administration, institutional arrangements, service delivery, justice, the fight against corruption, and the protection of human rights and fundamental freedoms. These developments led to the expectations that in the process of deepening cooperation with the EU, reform agendas in various areas will be reactivated.

The modernization of the public sector and the improvement of the delivery of public services have always played an essential role in terms of European integration and approximation to European standards. The Coronavirus pandemic has also shown the need for reform in this regard. To increase the efficiency and flexibility of the public sector, it is important to further enhance digital transformation. In this process, it is necessary to take into account the experience and good practices of other countries. Emphasis should be placed on those countries that have already successfully completed the European integration process, as well as those that are currently in the negotiation process. It will be important to consider their achievements and challenges/lessons learned.

Therefore, the conference aims to discuss good practices, main trends, as well as challenges and opportunities for Georgia in the field of public sector modernization and transformation using new technologies. The main topics of discussion at the conference will be: digitization and use of public services; creating favorable conditions/environment for digital transformation; and Georgia's opportunities and challenges in the digital transformation of the public sector.

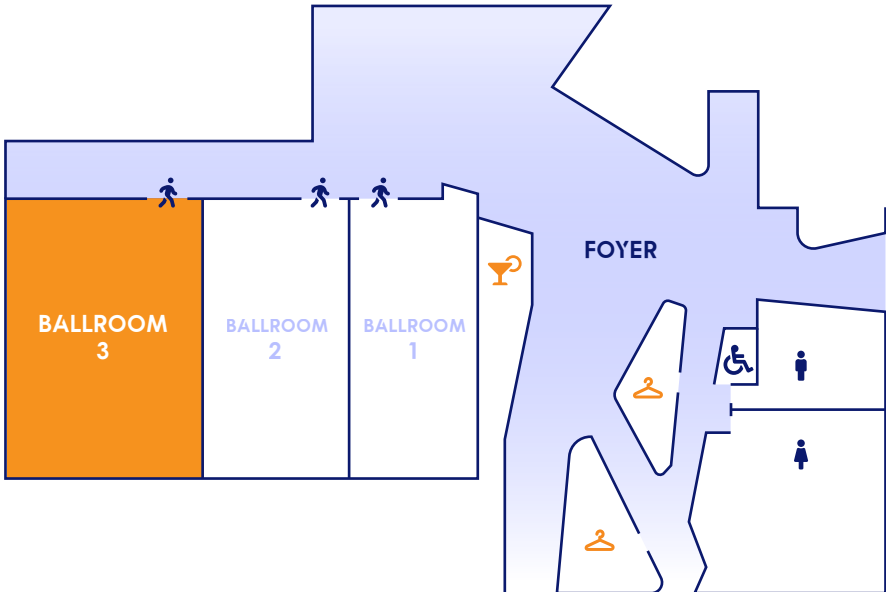

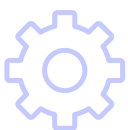


**MS. NATALIA CARFI**

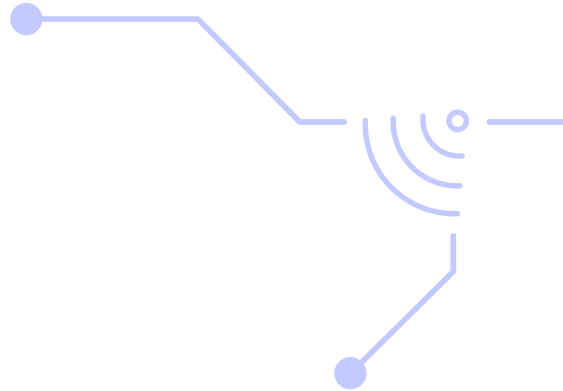
## MS. TEONA TURASHVILI

**MS. NATA GODERDZISHVILI**

Chief Cybersecurity Expert

Ms. Goderdzishvili provides 15 years of professional experience, out of which 11 years of dedicated work on the topics of cybersecurity, digital transformation, ICT policy, ICT regulatory and legal frameworks, information security policies and standards, strategy development, and implementation. She has all relevant legal know-how concerning the EU legislation, national ICT/e-governance legislation, good practices, and legal technics and skills on EU legal acquis transformation into national legislation. Ms. Goderdzishvili has in-depth knowledge of the specific legal and regulatory reforms in cybersecurity for the countries in transition due to her extensive professional experience in similar processes in Georgia.

Ms. Goderdzishvili is the only Georgian and among a few foreign experts holding the SANS Institute's Global Information Assurance Certificate in Legal Issues in Information Technology & Security (2013-2021).

Ms. Goderdzishvili has worked in governmental, non-government, international, and private organizations. While holding a Chief Cybersecurity mandate within the Data Exchange Agency and Digital Governance Agency of the Ministry of Justice of Georgia, she chaired the cybersecurity legal and policy drafting process in Georgia, with her direct contribution, Georgia adopted a legal framework on information and cyber security, critical infrastructure protection, privacy, and personal data protection, three sets of Georgian nation-wide cyber security strategies/action plans and numerous policy and analytical papers. She is well versed in strategic and regulatory issues related to IT and technology used in the public sector and society at large. This includes cybersecurity governance, critical infrastructure protection, incident handling standards, information sharing platforms, etc. She is well-capable to combine human, organizational, and process elements of cybersecurity– which is a rare combination of skills. She is an author and co-author of various policy recommendations and analyses, reports, articles, and presentations in the field.

Nata has years of working experience with cybersecurity professional communities, leading initiatives of cooperation between public, private and academic stakeholders within the scope of the Cybersecurity Forum of Georgia, ICT Business Council, a few examples. Nata successfully accomplished the very first attempts of establishing cooperative relationships between international projects and public-private cybersecurity stakeholders. Moreover, she was the lead expert drafting the national cybersecurity strategy of Georgia who worked with the UK technical team, she was in charge of ensuring that recommendations provided by the experts were fully reflected in the Georgian draft of the document. Last but not least, at Nata's invitation and local facilitation by the British Embassy in Tbilisi, the Global Cyber Security Capacity Centre (GCSCC) has conducted a review of the cybersecurity capacity of Georgia. The CMM Georgian report proved to be largely instrumental as objective evidence for consecutive work on the cybersecurity strategy of Georgia.

Importantly, Ms. Nata Goderdzishvili is very experienced in high-level political communication (She advises on e-government and security issues political decision-makers of foreign governments) and has useful skills in high-level leadership and communication. She is well standing on international forums as an invited expert and speaker for EU, CoE, OSCE, UN, NATO, and other high-level conferences and events.

Mr. Irakli Gvenetadze Digital Transformation Expert with almost 30 years of experience, including work for governmental, international, and private organizations. Over the years, the results of his work have influenced the institutional advancement of these organizations and contributed to improving their service delivery strategies through digital transformation, reengineering of the existing business processes, and introducing new and emerging information technologies.

For seven years (2010 – 2017), Mr. Gvenetadze chaired the LEPL Data Exchange Agency (DEA) of Georgia's Ministry of Justice, a principal governmental body to coordinate e-governance, information, and cybersecurity development in Georgia. According to ITU Cyber Readiness Index 2017, Georgia was ranked 8th among 193 countries.

Mr. Gvenetadze was involved in the implementation of such critical projects in Georgia as the Georgian Governmental Network; the Introduction of an e-filing system for tax administration; Data Exchange Infrastructure (interoperability platform); Citizen and business portal – my.gov.ge; Introduction of legislation for e-document, digital signature, unified register of information, and information security, drafting of Georgia's digital governance and cyber security strategy documents, etc.

Currently, Mr. Gvenetadze is working as an international expert with organizations such as UNDP, World Bank, Asian Development Bank, USAID and EU projects, etc.

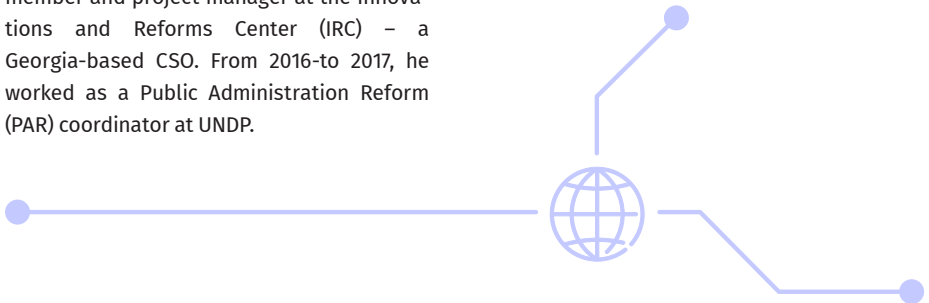
## MR. LEVAN SAMADASHVILI
