

Supplemental Agreement # 1  
by and between  
INSTITUTE FOR NON-VIOLENT COMMUNICATION  
and  
INSTITUTE FOR DEVELOPMENT OF FREEDOM OF INFORMATION

This Supplemental Agreement is made and entered into force by Institute for Non-Violent Communication (referred to, as “IncGeo”), a registered non-for-profit organization in Georgia, and by Institute for Development of Freedom of Information(referred to, as “IDFI”), also a registered non-for-profit organization in Georgia.

ARTICLE 1  
PURPOSE AND SCOPE OF THE SUPPLEMENTAL

1.1 Purpose. The purpose of this Supplemental Agreement is to enforce Article 2.2 of the Memorandum of Understanding, as signed by the organizations on January 15, 2015.

ARTICLE 2  
PROPOSED ACTIVITIES PURSUANT TO THE SUPPLEMENTAL AGREEMENT

2.1 Organizations agree, that IncGeo will apply to the U.S. Embassy Small Grants program in January of 2015 with a proposal to implement “Youth Engagement for Public Policy Solutions in Samtskhe-Javakheti and Kakheti” (YEPS) Program.

2.2 If the donor institution agrees to provide funding for the YEPS Program, then IDFI will support IncGeo with its institutional resources, such as (a) social networks platform; (b) web site hosting capabilities. Furthermore, IDFI’s staff member will be employed in the YEPS Program, in the capacity of (a) Social Media Coordinator (40%) and Financial Manager (10%).

ARTICLE 3  
TERM AND TERMINATION

3.1 Term. This Supplemental Agreement shall take effect upon signature by both organizations and, unless earlier terminated, will continue for a period of one year.

3.2 Termination. This Supplemental Agreement may be terminated at any time as a result of termination of the signed MoU or independently, by either organization upon written notice to the other; provided, that any ongoing activities will be closed at a reasonable date and condition.

ARTICLE 4  
MISCELLANEOUS




