

European Region Government Point of Contact Conference June 3-4, 2015

1. Introduction

A primary goal of the Open Government Partnership is to foster collaboration and learning within the open government community. We are planning a small meeting of European OGP governments in Tbilisi, Georgia on June 3-4 2015, co-hosted by the Government of Georgia and the OGP Support Unit. Government points of contact from European countries will come together to share experiences and learn from each other, as well as get first hand information from the OGP Support Unit, selected Civil Society leaders, Independent Reporting Mechanism, OGP Working Groups and multilateral partners. The objective is to further build the network of government reformers using OGP to advance ambitious open government reforms in their countries, and continue to inspire a 'race to the top' within OGP.

2. Objectives

- 1. Create space for countries to share experiences and learn from each other: Through facilitated discussions and dynamic team style sessions, participants will have the opportunity to contribute their insights and learn about innovative practices in matters related to the OGP process (such as co-creation of NAPs, consultation during implementation, and conducting thematic workshops) as well as in relevant issue areas (for example: public participation, open data, fiscal transparency, and public service delivery).
- 2. **Get feedback on new National Action Plans:** Give all countries producing new NAPs an opportunity to receive feedback from their peers on drafts.
- 3. **Identify requests for support**: Identify specific requests for country support and opportunities to improve assistance particularly through the Support Unit's Direct Country Support and Peer Exchange programs, OGP's multilateral partners, and the five OGP Working Groups.
- 4. **Provide basic training on OGP processes and timelines**: This includes training on the OGP calendar, NAP development, Self-Assessment reporting, and IRM Procedures.
- **5. Opportunity to network:**Provide opportunities for reformers in the region to get to know each other.

3. Participants

Working level government points of contact from countries in the region will be the main audience for the conference. OGP actors such as working groups, multilateral partners, civil society leaders and Support Unit Staff will participate as speakers and facilitators.
